



## **SEC and ECADA**

### **A Partnership Serving Essex County Student Athletes**

**2019**

**1. Eligibility:**

All schools must be members of the ECADA in good standing to be eligible to enter the **2019 Field Hockey** tournament. The tournament is a single elimination tournament open to all schools. A winning record is not required for entry. The tournament shall be played on the following dates:

**Preliminary Round:** NA

**Pre-quarters Round:** On or before Thursday, October 3, 2019 if applicable, at higher seed.

**Quarter Finals:** On or before Saturday, October 5, 2019 at the higher seed with rain date of October 6th.

**Semi Finals:** On or before Saturday, October 12, 2019 at higher seed with rain date of October 13th.

**Championship:** Saturday, October 19, 2019 at 2:30 PM at Essex Valley Field, W. Caldwell.

**Postponed games** shall be rescheduled on the following day if conditions are acceptable. The Tournament Director shall oversee the rescheduling of games and has the right to reschedule in order to prevent a deleterious scheduling situation for schools involved. Tournament contests take precedence over conference and independent contests. If the higher seeded team's field remains unplayable, the game will either be moved to a neutral site or to the lower seeded team's site if that field is playable and in better condition than the higher seeded team's site.

**2. Entry Fee**

The entry fee for the tournament is \$105.00. Please make the check payable to the "Super Essex Conference" and mail to

4. **Entry Procedure**

Entry into the 2018 Essex County Field Hockey Tournament must be submitted online through the Super Essex Conference website, [www.sec.powermediallc.org](http://www.sec.powermediallc.org) no later than noon on Monday, September 30, 2019.

**In order to ensure that sufficient recording of game results be documented for seeding purposes, the online entry may only be submitted between Friday morning September 27th until noon on Monday, September 30, 2019.**

Results of any games, which are played after the entry is submitted, must be phoned, e-mailed, or verbally transmitted to the tournament director by the start of the seeding committee meeting.

5. **Seeding**

The seeding meeting will be open to all entering schools. Only the head coach or his/her designee may attend. (Only one representative per school permitted). The seeding meeting will be held on **Tuesday, October 1, 2019 at 7:00pm at MKA Academic Center, 6 Lloyd Road, Montclair.**

6. **Officials**

All officials will be assigned by the SEC field hockey assignor. The higher seeded team is responsible for paying the officials up to the Finals. . The SEC shall pay the officials at the championship final. Official's fees are \$77 through the semifinals and \$87 for the final.

Contact **Tournament Director Injoo Han at Montclair Kimberley Academy** with site and time for each round. **This should be done by the Monday prior to the game.**

7. **Admission**

Admission for the Finals will be \$5.00 general admission and \$2.00 senior citizens and students.

8. **Automated External Defibrillator.**

Pursuant to NJ state law, Janet's Law, schools hosting any ECT game, match or contest must provide an AED on site. For events held at predetermined neutral sites all contestants must bring and have available for immediate need an AED for their team.

9. **Deadlines**

Please adhere to all the tournament deadlines.

10. **Proper completion of Entry Forms**

Properly complete all required entry forms and adhere to the instructions on each form or the instruction within the aforementioned tournament rules and regulations.
